The contract had an “Initial Scope” funding value of £111,601,364 and a “Deferred Scope” funding value of £7,376,636. Following the modification, the initial scope committed funding value has increased by £3,758,636 to £115,360,000. The Initial scope premises have increased by 4,003 from 43,795 to 47,798.
