The Development Partner must have collective experience in the construction of affordable, specialist accommodation and private housing, commercial space, and high quality public realm.

The development partner would also be responsible for delivering an energy solution for the full site.
- Use of a local or national framework to deliver construction works creating serviced plots for sale following design works completed by the Council's appointed design team
