This is a Provider Selection Regime (PSR) intention to award notice. The awarding of this contract is subject to the Health Care Services (Provider Selection Regime) Regulations 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award. The publication of this notice marks the start of the standstill period. Representations by providers must be made to decision makers by midnight on 15 March 2024 via email to [serviceteam.procurement@somersetft.nhs.uk](mailto:serviceteam.procurement@somersetft.nhs.uk). This contract has not yet formally been awarded; this notice serves as an intention to award under the PSR. The decision makers were: Deputy Service Director – Surgery and Critical Care Group. No conflicts of interest were declared among decision makers. The key criteria were weighted as follows: 30% quality and Innovation, 30% Value, 15% Integration, Collaboration and Service Sustainability, 15% Improving access, reducing health inequalities and facilitating choice, 10% Social value. Quality and value are the most important factors to ensure a high quality, safe and effective service can be provided to as many patients as possible to minimise waiting times. The rationale for choosing the provider with reference to the key criteria: The existing supplier is an established surgical services provider with a proven track record, and they are highly likely to be able to satisfy the new contract to a sufficient standard.
