The contract will be for a duration of 10 years with the option to extend for up to a further 5 years with an estimated contract value (including 5-year extension) of £17,881,935.00.

The Windmill Practice is a member of the Nottingham City East Primary Care Network. The practice has approximately 10,832 (raw list size) registered patients as of October 2023. The list size has slightly grown over a period of 18 months. The immediate areas of the practice boundary have high index of multiple deprivation and tend to experience the most health inequalities.

The contract will be awarded to Modality MMS following a robust Competitive Process under The Health Care Services (Provider Selection Regime) Regulations 2023.

The award criteria is the Key Criteria, with a weighting of 100.
