The successful tenderer will be required to provide excellent catering services to The Maplesden Noakes School, which has 1413 pupils of which 28% are pupil premium, and 190 teaching and support staff.

The contract term being tendered is for three years, 1st August 2026 – 31st July 2029. There is an option for a further extension period for up to two additional years to 31st July 2031.

The contract offers an excellent opportunity to review and propose enhancements to the current catering services at the School. This includes but is not limited to; breakfast, morning break, lunchtime and after school services, over the academic year, plus hospitality services upon request.

The school is keen to secure a high quality catering service including fresh locally sourced ingredients prepared on site, with a menu design that is flexible to suit the requirements of the school's specific students. The school requires a balanced, healthy offer that is popular with its students. Maplesden Noakes is proud of its 'family ethos' and expects both a tightly managed service and a management style delivered by the successful contractor that supports, encourages and develops the catering staff. Strong marketing and engagement initiative are sought and the capability to manage or interact with the school's cloud-based digital signage would be welcomed.

- The minimum annual turnover that your company must have achieved to be considered for this opportunity is £1 million
- There are not any incumbent catering staff currently within the Local Government Pension Scheme
- The catering services are currently contracted to Impact Food group
- Capital investment would be welcomed.
