II.2.4) Description of the procurement

Level 2b Residential Neurological Rehabilitation Service provides rehabilitation for people with more complex neurological disease or injury. This centres around enabling people to achieve optimal functional levels, managing residual impairments of neurological damage and achieving the best possible quality of life within their local community following discharge. This will be achieved through the application of a holistic person-centred approach to rehabilitation which is integrated seamlessly with all other health, social care and voluntary services.

This service is aimed at adults over the age of 18, however, consideration will be given to those nearing the age of 18 years old by exception on a case-by-case basis, in discussion with service providers, families, CQC and SNEE ICB.

Short Stay Neurological Rehabilitation is available to all individuals registered with an Ipswich and East Suffolk and West Suffolk GP who meet the clinical need as set out in the specification.

The service will deliver six (6) permanently established beds within the Suffolk locality at The Chantry Neurological Centre, Ipswich.

The NHS Standard Contract (Short form) will be for five years and cease on 31 March 2029. The contract will be subject to inflationary uplifts.

NHS Suffolk and North East Essex Integrated Care Board are awarding the contract named within this notice under the Direct Award C process which is outlined within the Health Care Services (Provider Selection Regime) Regulations 2023. The provider named in this notice is an existing provider and has been reviewed through a Key Criteria assessment to ensure the awarding body is satisfied with current performance and reasonably expects the provider to be able to satisfy the contract which is the subject of this notice.
