The service can only be provided following an assessment of need and if certain thresholds are met. This service is not exclusively for disabled children and young people although they make up the vast majority

of service users. Two broad areas of domiciliary care include:

- (i) domestic tasks; and
- (ii) sitting service.

It is anticipated that all tenderers that meet the quality threshold, described in the ITT document, will be accepted onto this lot. Services will then be called off as and when required by Leicestershire County Council following the call-off procedure described within the service specification.
