7.5 The NENC ICB (South Tyneside Place) has agreed that subject to:

- the cessation of all activity deemed for cosmetic reasons;
- the adherence of practices submitting provisional diagnosis and indication for surgery as part of the data submission,

that all financial and activity caps that have previously related to the provision of this service will be removed from 1st April 2018. Any activity undertaken which is subsequently deemed to have been for cosmetic reasons will not be reimbursable.
