NHS Bedfordshire, Luton and Milton Keynes (BLMK) ICB was seeking independent sector hospital service(s) providers for the provision of elective care services which meets the ICB's requirement on a set of standard terms and conditions. The proposed contract relates to healthcare services in respect of which the patient is offered a choice in relation to the provider. This is a consultant led choice service and therefore meets the requirements of a choice lead service for patients (as set out in Part 8 of the NHS Commissioning Board and Clinical Commissioning Group (Responsibilities and standing rules) Regulations 2012). The service provider was required to operate a site offering the relevant services from within the BLMK ICB geographical area that the ICB considers appropriate to enable its patients to access the services.
