The authority is preparing to launch a procurement for a national cyber threat detection and reporting platform under a Competitive Flexible Procedure.

This service will replace and enhance the existing Police Cyber Alarm system.

- Invite suppliers to participate in early engagement activities.
- Gather insights to help finalise the tender documents.

- Support threat detection, alerting and pattern recognition.
- Provide scalable and secure cloud-based processing, storage and querying capabilities.

- Integrate with law enforcement and threat intelligence services
