Hull City Council (The Authority) has entered a standstill period to award three contracts to two suppliers. The tender is split into 3 lots with sub lots. The tender exercise was done via the open procedure consisting of a one stage process via the Light Touch Regime.

- o Total cost for the initial 3 year contract period is £1,852,140.00.

The Framework agreement provides for contracts to proceed from 1 April 2026 for an initial period of three years, with subsequent option(s) to extend the contract arrangements beyond the initial term for a period, or periods of two further 12 months at the discretion of the council and based on contractor performance.
