This is a requirement for a Provider with a minimum of three years of experience of delivering medically managed Inpatient Detoxification Services that achieve positive outcomes for the people accessing the service.

The Provider is required to provide the residential facility and the withdrawal and stabilisation services. The residential facility must be within one of the local authority

areas represented by the East Midlands Consortium.

The Provider will also be required to administer the service which will include co-ordination and monitoring of the referrals into the service with the aim of ensuring the allocation of bed days in the service is relative to the funding allocation for each authority.
