The Institute for Gravitational Research requires a large scale accessible vacuum system to be used for prototyping next generation room temperature fused silica mirror suspension technology for 3rd generation gravitational-wave observatory infrastructure. These instruments will extend the range of gravitational astronomy by at least an order of magnitude. The UK will be a key future contributor to this research, co-developing the conceptual design of the next generation of interferometer mirror suspension technology. To prototype and de-risk future suspension technology, the vacuum system should have minimum dimensions of 2.7 metres tall with 1.2 m by 0.8 m rectangular base footprint. Other uses will include testing of Birmingham/Glasgow collaboratively produced 6D sensors.
