The Delivery Authority was established pursuant to the Parliamentary Buildings (Restoration and Renewal) Act 2019 and has duties under the Act in relation to the restoration and renewal of the Palace of Westminster and the delivery of the Parliamentary building works (as defined in the Act) as part of the Restoration and Renewal (R&R) Programme.
