performed by the Client;
upon such terms as the Client proposes, provided that where such novation increases the burden of the Provider's obligations pursuant to this Deed, the Provider is entitled to such additional payment as may be reasonable to compensate for such additional burden.

Any change in the legal status of the Client such that it ceases to be a Contracting Authority does not affect the validity of this Deed. In such circumstances, this Deed binds and inures to the benefit of any successor body to the Client.

Special Condition 2

(Novation B)

The Client is entitled, without the need to obtain the Provider's consent, to novate its rights and obligations under this Deed to a design & build contractor engaged by the Client to construct the works incorporating the designs produced as part of the Commission.

The novation will be on such terms as the Client proposes, provided that where such novation increases the burden of the Provider's obligations pursuant to this Deed, the Provider is entitled to such
