The Festival is being curated, managed and promoted by Festival 2022 Limited in collaboration with VisitScotland, Creative Wales and Belfast City Council and is funded by the UK Government, the Scottish Government, the Welsh Government and the Northern Ireland Assembly.

This notice has been published prior to VisitScotland entering to a commissioning contract in respect of the Project. VisitScotland will observe a minimum period of 10 days from the date of publication of this notice before entering into a commissioning contract in respect of the Project.
