- Supply and installation of showering facilities to include removal of bath, making good to wall plaster, installation of or provision of stepped or level access shower trays for floor coverings.
- Conversion of other rooms into shower / wc rooms
- Installation of wash/dry toilet
- Supply and installation of specialist kitchen facilities
- Alterations to existing internal structure to improve access around the property (widening of door openings etc.).
- Safety works, including safety fencing
