II.2.4) Description of the procurement

The FBS panel is a representative sample of around 1750 full and part-time farms across all farm types across England. The data collected covers all aspects of the farm business; both financial i.e., output value and costs relating to all farming enterprises; diversified activities; revenue from agricultural support and agri-environment schemes, and physical as well as labour and geographical characteristics.
