Poetry forms an important part of the National Curriculum for English at all key stages, as well as the specifications for English Literature GCSE and A-Level English Literature. The Government wants to encourage schools to improve pupils' knowledge and enjoyment of poetry as part of a structured, knowledge-rich curriculum. The competition will develop and support inspiring poetry teaching in schools and motivate pupils and teachers to explore our rich literary heritage.

The supplier will curate an interactive, online anthology of poems, with accompanying information and context, covering 1,000 years of poetry and representing the best of our literacy heritage. Pupils in Key Stages 2, 3, 4 and 5 select poems from the online anthology and recite these in school-based competitions.
