The provider and/or developer is expected to operate these services for Residential, Dementia, and Nursing care in partnership with the Council.
- The Council currently has 12 residential care homes, and the contract ends on the 31st May 2026. We would be looking for the new care provider / property developer to operate the service from 1st June 2026.
- The Council are interested in hearing from care providers and property developers and the event will be an opportunity for the council to share its direction in providing older persons care home accommodation.
