Digital Staff Passport Framework - The need for the NHS to have a flexible and responsive workforce has been set out in both the NHS Long Term Plan and the NHS People Plan.

The ambition now, as set out by the NHS National Director for People and National Director of Transformation, is to make digital staff passports available to substantially more staff servicing different types of staff movements as soon as practicable.

To support this ambition, NHS England want to better understand what the providers of digital passport technologies are able to offer and establish a new framework service line for digital staff passport providers under the Health System Support Framework (HSSF) to ensure a broad and open market is created.

Further to this PIN notice NHSE wishes undertake a tender process to initiate a multi-supplier framework agreement, so that potential authorities can undertake call-offs as and when required in line with framework Terms and conditions.
