FIREDOOR SPECIFICATIONS

- All classrooms, offices, and meeting rooms will include vision panels in fire doors.
- Existing doors and frames will be removed and disposed of off-site.
- Year 5 and Year 8 corridors will require new surrounding frames to accommodate double door sets.
- All fire breaks and over-cladding will adhere to a 30-minute fire retardant rating.
- All door sets will be 30-minute fire-rated in oak veneer.
- Fire-rated hinges, handles, locks, and kick plates will be used.
- RAMS (Risk Assessments and Method Statements) will be provided before commencing work.
