## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

The length of contract will now change from 48 months initially projected to 52 months, in addition to this the value foreseen will therefore increase from 20000000.00 to 30000000.00.

### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

The anticipated contract length and value of this procurement has been extraordinarily impacted by a change in regulations, around conducting of external body reviews, namely in this case the framework host trust and review of the framework renewal tender documents. In order to renew the framework, an additional 4 months has been applied, to conduct a full open procedure tender process.
