This contract has been awarded under the Health Care Services (Provider Selection Regime) Regulations for 2023. For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award.

Regulation 14 was applied because a delayed mobilisation would have resulted in longer patient waits, undermining NHS England elective recovery requirements, including progress against 52 week and 65 week waits.
