Price will be evaluated based on a maximum of 80 marks (weighting - 80%) for the lowest priced compliant tender (subject always to the provisions noted above in relation to

abnormally low tenders). Other tenders will be awarded a number of points in direct proportion to the relation between their tendered price and the lowest tendered price

The scores for all criteria will be totalled to give an overall score. The Council intends to select the supplier(s) with the highest overall score(s) as its successful supplier(s).
