There are 29,000 properties in the six towns (West Bromwich, Oldbury, Smethwick, Tipton, Rowley Regis and Wednesbury) in Sandwell. The Council cannot determine what percentage of goods will be delivered to the Supplies section and what percentage of goods will go directly to the tenant's properties.
