- Promoting the online Chlamydia Screening Programme and raising awareness about sexual health issues.
- Offering clear guidance and referrals to sexual health services.
- Strengthening the local network of contraceptive and sexual health services for easy access.

- Providing advice on condom usage and increasing awareness of STI risks.
- Supplying information packs and signage as specified.
