**II.1.4) Short description**

There are 13 closed protocol intruder alarms and one fire alarm within Council and SLLC properties throughout the South Lanarkshire area which were installed by Stanley Security Solutions Ltd (Stanley) as a result of an architect's design, when the properties were built.

The Council therefore require to procure a contract with Stanley Security Solutions to undertake all inspections, routine servicing and monitoring, maintenance, repair and / or replacement of parts identified during maintenance visits; call outs to reset the systems or to repair as necessary to ensure the satisfactory operation of the intruder systems within those properties.

The works comprise a service and maintenance contract covering two service visits per annum and emergency call outs for repair work or resetting the system subsequent to an activation including false alarms and break-ins.
