Cheshire East, a Unitary Authority, has 185,000 households and covers with a mix of rural and urban areas. All properties within the borough are offered a wide range of recycling options, including garden waste collections.

The Council will now be bringing in a charge for the garden waste service and as part of this service. This system will require permits for the residents who subscribe to the service. The Council requires the design, printing and posting of the permits to residents who subscribe.
