- Correction to (2025/S 000-042949). This modification should have stated that the original contract value of £17,043,000 reduced to £16,371,344, and the number of

premises reduced from 5,572 to 5,311.

- New contract modification. The contract has been modified again resulting in an updated contract value of £15,493,563, and 5,034 premises.
