VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

This modification is made at the discretion of the relevant authority and does not render the contract materially different in character. The cumulative change in the lifetime value of the contract compared to its value when it was entered into, is under 25%.

Due to diagnostic activity now being funded via a separate CDC contract, it will be required to recurrently reduce the block value of the main contract by the corresponding value.

This modification is to make this reduction for the financial year 2024/2025 only and reduces the contract value by £1,897,354

Lifetime contract duration remains unaffected
