The contract is for 1 year plus 2 option years estimated to start February 2026. The contract is for continuous support, Maintenance and Repair of the current Inservice capability of PSUATE. The Contract has a proposed Value of £0.652M (Inclusive of VAT)

The authority considers that the direct award of this non-competitive contract falls within the circumstances set out in the Procurement Act 2023 Sch. 5, Para. 6(a)(b):

6. The following conditions are met in relation to the public contract-

a) Due to an absence of competition for technical reasons, only a particular supplier can supply the goods service or works required, and

b) There are no reasonable alternatives to those goods, services or works.
