DHSC currently structure the hierarchy within the system to allow flexible and compliant reporting, analysis and data reconciliation. It is expected that DHSC would continue this maintenance of structures and rules framing the hierarchies. DHSC would also like to procure a technical support service to aid with arising issues and help advance the efficiency and usability of the acquired system. We are publishing this PIN to understand from the market what products are available, high level potential implementation timescales, high level costs and to test whether our requirement is of interest to the market.
