- The incumbent provider has delivered the following key criteria

- 1: Quality and Innovation with a value of 25% by achieving the contractual KPIs,

- 2: Value with a score of 20% by providing a service that is value for money compared to other providers,

- 3: Integration, collaboration and service sustainability with a value of 20% by collaborative working within the local system,

- 4: Improving access, reducing health inequalities and facilitating choice with a value of 20% by reducing health inequalities,

- 5: Social Value with a value of 10% by ensuring the provider is meeting London Living Wage (LLW). The existing provider is satisfying the original contract and will likely satisfy the proposed contract to a sufficient standard.

The provider has been selected based on the combined scores which confirms the providers ability to continue to fulfil the contract in line with PSR - Direct Award Process C.
