Provision to ensure ex-offenders have opportunity to occupy their time and learn new skills to reduce the chances of them reoffending.

We will offer learning opportunities that allows them to maintain positive activity in order to reduce the possibility of them reoffending.

We will incorporate maths into the delivery of subjects such as painting and decorating; basic household DIY and maintenance; How to become self-employed; Basic computer skills, prisoners do not have access to computers and often technology has moved on since their incarceration; Making and crafting. We will work closely with our partners at HMP Hull to ensure that all learning offered is attractive to the prisoner and enables them to improve their maths skills.
