For the avoidance of doubt, the provisions of the Public Contracts Regulations 2015 do not apply to this award.

This contract has now been formally awarded using direct award process C.

The contract award date is 9th April 2025, and the standstill period took place between 13th March 2025 and 25th March 2025. The business case including the recommendation to award the contract under Provider Selection Regime Process C was approved by the ICB's Strategic Finance & Commissioning Committee on 9/1/25 and one potential conflict of interest was noted and mitigated.
