This Prior Information Notice alerts the market to a forthcoming procurement opportunity for Prevention & Early Intervention services. Please note that the details are provided to inform potential bidders but remain subject to change as specifications and strategy are finalised, with no commitment implied.

Lot 2: Information/ Advice for Older People: £170,000

Procurement Approach: Standalone Open Tender with lotting (2 lots), service commencing 1 January 2026. Social value (min 10% weighting) focuses on local employment, SME support, and community engagement. Mandatory requirements may include but are not limited to 2 years' experience or equivalent, compliance with FSA regulations, £250k turnover, ability to mobilise locally and compliance with safeguarding standards.
