- 3: Integration, collaboration and service sustainability with a value of 16% by collaborative working within the local system,

- 4: Improving access, reducing health inequalities and facilitating choice with a value of 20% by reducing health inequalities,

- 5: Social Value with a value of 10% by ensuring the provider is meeting London Living Wage (LLW). The existing provider is satisfying the original contract and will likely satisfy the proposed contract to a sufficient standard.
