The Trust are exploring the market to find a supplier to dispense outpatient prescriptions (the Service) for the UHNM TB Service held at the Cobridge Community Health Centre, Church Terrace, Stoke-On-Trent, Staffordshire, ST6 2JN and to ensure that the service is conducted in a consistent, professional and accurate manner.
