This is achieved through the installation of additional security measures within the home such as door cameras, fire safety measures, increased security on easily accessible doors and windows and, where necessary, the creation of a sanctuary room which provides victims/survivors a safe place to wait for the arrival of emergency services.

Therefore, selection and award criteria, specification requirements and contract performance conditions may relate in particular to social and environmental considerations as relevant to the subject matter of this project.

The Council reserves the right not to award the framework, as a result of this Contract Notice. The Council shall not be liable for any costs or expenses incurred by any organisation in responding to this notice or in tendering for the proposed framework.

All submissions must be in English, with any clarifications or discussions conducted in English. Tenders and supporting documents must be priced in pounds sterling and all

payments under the proposed contract will be made in pounds sterling.
