The Authority's requirements in terms of the delivery of a Older Persons Floating Support Service. The age eligibility criteria for the service is for adults who are over 60 years old 150 Support hours, inclusive of direct management hours, will be delivered per week on a basket of hours approach depending on needs of the individual. The service users will have been identified as living in Brent and needs will range from low, medium to high. The service will reduce and minimise the risk of admission to hospital, and residential and nursing care, along with reducing risks of falls and accidents at home, which could lead to a loss of independence.

Many service users will require the support for a period of up to 18 months however some older people will require support long term. There is therefore no maximum time any individual should stay in support service should however anyone staying in the service post 2 years should seek approval from the Council.
