The regional fleet is a mixed fleet of 2/3 car Class 170 and 2 car Class 158.

EMR is seeking a supplier to provide competent resource to attend the sidings in order to complete the following services, Tanking, toilet extraction (CET tanks) and interior and nose end cleaning.
