To provide timely discharge for adults from hospital as part of the discharge to assess model. This will move life changing care decisions outside of the acute hospital environment, allowing time for adults and their families to make informed decisions and reach long term plans where a further assessment cannot be completed in the adult's home. Promote independence and improve outcomes for adults recovering from illness, injury, or trauma by providing individualised support to enable them re-gain sufficient physical functioning and confidence.
