The objective was to make working from home using Office365 for NHS Trust staff across Wales resilient as the effects of COVID-19 developed. By adopting this approach a resilient service was provided to those working from home to undertake their daily activities. Other aspects of the solution to be rolled out included applications to manage communication to all staff in relation to latest news on COVID-19, a self-diagnosis tool to ease pressure on NHS Wales and Frequently asked questions.

The programme has been successful in enabling the O365 nationally but there are several key deliverables, from a technical and product requirement perspective, that can be delivered with the provision of additional resources, i.e. achieve “Good Security Posture”, which is the minimum level of configuration that should be met for organisations purchasing E3 licences. The additional support is expected to be completed by 31 July 2021, at the latest and will allow the O365 Programme to complete the technical functionality as well as demonstrate the full product benefits, including the office communicator and future application innovations.
