Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

It has become apparent that the initial 729370GBP sought in the previous direct award for the requirement does not cover the spend required for the awarded supplier to provide service to the Authority until 01 August 2021, at which point the full regulated procurement procedure (currently in progress) will be at award stage. It is estimated that 200000 GBP is required to cover this period.
