## **VII.2) Information about modifications**

### **VII.2.1) Description of the modifications**

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

It is intended that the contract term be increased from 84 to 86 months (i.e. the addition of two months) to facilitate the completion of the current tender exercise, reference 3970566 which was advertised 29.04.2023. The advertised value of the original competition ranged from 1100000 to 10000000. No amendment to the original value is required to facilitate the additional two month extension.

### **VII.2.2) Reasons for modification**

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

72(1)(b)(ii) would cause significant inconvenience or substantial duplication of costs for the contracting authority. The current contract has been in place for almost seven years. A new tender opportunity was advertised 29.04.2023 but is unlikely to be concluded before the expiry of the existing contract. To establish a new or interim provider for the additional two months required to facilitate completion of the tender exercise would not be feasible and would lead to duplication of effort and costs given the status of the current tender exercise and its likely conclusion by August 2023.
