The purpose of the commission is to advance the Net Zero goals and ambitions of North Northamptonshire. North Northamptonshire Council (NNC) are looking to appoint a suitably qualified consultant to produce a Local Area Energy Plan (LAEP) for North Northants. The LAEP will be an integral part of the Roadmap to Net Zero Action Plan and new Local Plan for the North Northants area. This energy strategy is critical as it will underpin the Council's climate emergency response and act as a framework to inform policy, planning, investment, and wider collaboration with key stakeholders to deliver Net Zero targets, including through the Big50 initiative.
