The objective of NHS Blood and Transplant (NHSBT) is to save and improve lives with the aim of being the best organisation of our type in the world. Procurement of a Statistical Process Control (SPC) Data Management Software System contributes to meeting these objectives. The SPC Data Management Software System must support data entry and reporting to allow both single datum and combined data analysis and review. The System must provide functionality to ensure data integrity and audit trail. The minimum system functionality will include the ability to build data sets by secure manual data entry to the system.
