It is vital in the meantime that the current system continues to run, ensuring Welsh government reporting requirements are satisfied. This is to ensure that Welsh Government statutory returns can continue be produced, and essential business intelligence information is available to Health Boards/Trusts.

The organisation intends to use the negotiated procedure without prior publication in accordance with the use of Public Contract Regulations 2015 32 (2)(b)(ii) and (iii), competition is absent for technical reasons and additionally (2)(b)(iii) - the protection of exclusive rights, including intellectual property rights.
