The Multiply programme forms part of the UK Government's Shared Prosperity Fund, that has been developed to support the government's wider commitment to level up all parts of the UK and provides funding for local investment between 2022 and 2025 and aims to help transform the lives of adults by improving their functional numeracy skills through free personal tutoring, digital training, and flexible courses.

UKG Multiply Programme will run up until the 31st March 2025.

The eligible participants within Multiply are:

Adults 19+ who have not previously attained a Level 2/ SCQF Level 5 or higher maths qualification. They can either be working towards a maths Level 2/ SCQF Level 5 or Functional Skills Qualification, need specific numeracy skills for their work or progression, or just want to brush up on the skills to help them get on in life and work.

The eligible interventions within Multiply are:

Courses designed to increase confidence with numbers for those needing the first steps towards formal qualification.

Courses for parents wanting to increase their numeracy skills in order to help their children and help with their own progression.

Courses aimed at prisoners, those recently released from prison or on temporary license.
